Childcare Workforce Recruitment and Retention – advice for early years and childcare providers

We know that recruitment and retention of staff is one of the sector's biggest challenges. Childcare Works have created <u>Advice for early years and childcare providers (PDF)</u> to support you with childcare workforce recruitment. This resource includes:

Early Years Service Wraparound Project

Primary schools are being supported to provide wraparound care for children in reception class and above between 8am and 6pm, for parents who require it. This is the first regular update for all wraparound providers.

Many fancy dress costumes are not manufactured to the same safety standards as normal clothing, meaning they can ignite almost instantly and burn far faster.


That's why it is crucial to ensure children wearing Halloween costumes are kept well away from naked flames and other heat sources at all times.

2-year-old early learning funding for families receiving additional government support



Children in receipt of the 2 year old early learning funding for families receiving additional government support, can start and be funded from any point in the term. If an eligible child is already old enough to take up their funded place, they will be eligible from the day they apply 2 year old Early Years Education online application. Please submit an adjustment claim form as soon as possible rather than wait to complete the provisional/ final claim form.

Application for Provisional Disability Access Funding (DAF) 2025/26

We understand there can be a wait for families to hear about whether they have been given Disability Living Allowance (DLA). To support your inclusive practice, settings will continue to be able to apply for Provisional Disability Access Funding once a parent has received confirmation of their application.

Please use the form below to request the Provisional Disability Access Funding. Any payments will be *made into the same account as your EY funding on the Final Claims.

We will monitor the waiting lists through the year and decide whether we need to allocate Provisional DAF in this way each term.

Through discussions we will explore effective ways to develop a shared understanding of what is quality practice within EYFS and effective strategies to improve teaching across a team. It will look at the requirements of Ofsted and how both the EYFS framework and Ofsted inspection framework work together, identifying key features of both documents. We will reflect on current trends, curriculum, and the enabling environment to enrich your professional knowledge of outstanding early years and focus on how to shape actions for the future development of your EYFS.
